2011-12 ENROLLMENT AND TUITION AGREEMENT

This agreement is made and entered into on the ____ of _____, 20____ between Mountain View Montessori School, hereafter referred to as the School, and the parent or guardian who is enrolling the following named child and whose signature is below, hereafter referred to as You.

The School agrees to admit the child for the session marked on the APPLICATION FOR ENROLLMENT form beginning on the ____ day of _____, 20____. You agree to pay the tuition in accordance with the terms and conditions of the Program and Tuition Rate Schedule published by the school. It is understood that the payment of the registration fee is a commitment to enroll and not subject to refund. You agree that said tuition is an annual tuition fee, based on the academic school year, and is not subject to adjustment or refunds. You understand and agree that by enrolling the above child, You are entirely responsible for making the full tuition payments to the school regardless of any agreements You have with other persons or payment assistance programs. In the event You wish to withdraw your child, the School must be notified in writing 30 days prior to the withdrawal. Tuition for the remaining school year will be due and payable until such notice is received. Due to the nature of the school year, 30 days notice will not be accepted after May 15, and You will be responsible for paying the remainder of the annual tuition fee.

You understand and agree that Mountain View Montessori shall have the right to exclude any student from attendance at school, temporarily or permanently, who is deemed in the discretion of the School Administrator and School Staff members, to be interfering with the health, safety, or educational development of himself/herself or of any other student(s) in the school. If payments are overdue, the School reserves the right to suspend your child's attendance until payment is up to date. Tuition will continue to be due during the child's absence.

Application for Enrollment, Program and Tuition Rate Schedule, Health and Authorization forms are attached hereto for completion and are made a part hereto. You agree that You and your child will adhere to the policies of the School as set down in the Family Handbook and the aforementioned forms. By signing this agreement, You agree not to hold the School, the School Administrator, or the School Staff liable for accidents arising from their child's non-adherence to said policies. The School reserves the right to change or revise any policy pertaining to the operation of the School after giving 30 days notice.

In connection with any litigation arising out of this contract, Mountain View Montessori School, if judged the prevailing party, shall be entitled to recover reasonable attorney fees and court costs.
